

PRIVACY POLICY

We at Global Markets Group Limited recognise the importance of protecting your personal and financial information.

As a Financial Conduct Authority ("FCA") authorised and regulated financial institution, Global Markets Group Limited must obtain personal information about you. This information assists us in servicing your relationship with us. We know you may be concerned about what we do with this information, and with the financial information about your account.

1.1.1. You have our assurance that:

- We are committed to safeguarding your privacy online;
- We only use your personal information to help us service your account, to improve our services to you and to provide you with products you have requested;
- We do not sell, rent or exchange your personal information with any third party for commercial reasons;
- We may share selected information with agencies and contractors working on behalf of Global Markets Group Limited as part of normal business operations (e.g., to email you about a service issue or post you any form you may have requested);
- We may share selected information with companies that help us process transactions for your account e.g., executing transactions;
- We may need to share your information with third parties for marketing purposes. If you would prefer us not to pass on your information, please notify us at info@gmgmarkets.com;
- This data sharing might include the secure export of your personal details overseas for the reasons stated above in this instance personal information will be handled consistent with UK regulatory requirements and Compliance obligations established under foreign law;

- We may also share your information for regulatory purposes as required by the Inland Revenue, FCA and other regulatory and government entities so authorised;

- We will provide you with notice of any changes in our information sharing practice; and
- Under the terms of the Data Protection Act, 1998 you are entitled to a copy of the personal data held by us on payment of a fee. Global Markets Group Limited will provide you with access to information we maintain on your account

1.1.2. How do we keep your personal information safe?

- We protect your account information by placing it on the secure portion of our servers. You will be advised of a unique User ID and Password at the outset of our relationship for use each time you want to access your account information. In addition, you can use the Log Off button located throughout the site to securely exit your account without closing your browser. Your login details should never be shared with anyone;

- When you access our site using any browser, Secure Sockets Layer ("SSL") technology is used to protect your communications through the server authentication and data encryption;
- Global Markets Group Limited does not collect personally identifying or sensitive information about you except when you specifically and knowingly provide it. We may confirm data you supply us with by using the due diligence you have provided;
- Global Markets Group Limited use a technology called "cookies" as part of normal business procedure. A cookie is an element of data that our website sends to your browser, which is then stored on your system. You can set your browser to notify you when you receive a cookie, giving you the chance to decide whether to accept it however, if you decide not to accept a cookie from Global Markets Group Limited, you may experience difficulties in using our website and we cannot be held responsible for any situations arising because of this;
- Cookies contain information about your account(s), and / or identifying information that you have previously provided to us. Without the information, we may not be able to complete your web transactions securely. Cookies help us to confirm your identity after you have logged in; and
- Global Markets Group Limited use cookies for the purpose of enabling website users to access information that has been tailored to their particular requirements, and also to facilitate the ease of use of Global Markets Group Limited's systems globally.
